SUB: Seeking immediate intervention for the reconsideration of conducting Suspicious JTO(T) LICE on 07/08/2022 against VY-21 even after the direction of Hon'ble Court Direction on 3<sup>rd</sup> Aug'22 to consider the Exam of VY-18,VY-19 and VY-20.

Respected Sir/Madam

Being disappointed on the Apex Management about the biased decision among different Cadre, my pen compelled to draw your attention to write this letter on behalf on the entire JE fraternity.

Despite of our several plea for our legitimate demand ,No fruitful intention of Management was noticed to consider pain of JE cadre which forced Our JEs to move Hon'ble court for the Justice and Hon'ble Court passed a Direction and that copy attached herewith and notable point that has been mentioned

previous year.

However, in case, at any stage, it comes to their notice or is determined that there were vacancies accruing in the years prior to 2021, they shall be legally bound in

Chandigarh Bench to hold the examination separately for those years, strictly in terms and conditions set out in said order of C.A.T. Chandigarh Bench.

We would like to emphasize that while passing this limited direction and observation, we have neither

And CAT Chandigarh Judgement Copy also attached to make things clear that Vacancy Yearwise Exam should be conducted and as per the statement of the Judgement passed on 3<sup>rd</sup> Aug'22 by Hon'ble PCAT that vacancies accruing in the year prior 2021, BSNL Management is legally bound to conduct the exam and we have the evidence of it where Vacancy of approx. 7500 JTOs were available for the justified promotion and its copy attached.

From the above illustration, Conduction of JTO(T) LICE in hurry on 07/08/22 against the VY-21 is meaningless which will create much more obligations for the career of JEs as things are under SUBJUDICE.

If Still Management is willing to conduct this exam then this will not only the steps to demolish the career of JEs in BSNL but will also termed disrespectful attitude towards the Hon'ble court and JEs of BSNL will be demotivated even after having Revival 2.0 Package.

We don't need any favour but we need a fair chance against our rightful demand and Demotivation activity towards JE cadre will never bring fruitful aspects as their strong belief for their beloved organization will be demolished.

We expect an urgent intervention put things on hold and reschedule the JTO(T) LICE of VY-21 till things are not settled properly.
